# Santa Rosa County Voter's Guide 2024



## **REGISTERING TO VOTE:**

Registering to vote is easy. You will need your Florida Driver's License number, Florida ID number, or the last four digits of your Social Security number.

If you register by mail, are a first-time voter, and have never been issued a Florida Driver's License number, Florida ID number, or Social Security number you are required to provide additional identification. These acceptable forms of identification are outlined in Approved Identifications. Please do not send original documents with the application form.

Online voter registration is available at VoteSantaRosa.gov.

To register in person, simply complete a Florida Voter Registration Application at an authorized voter registration agency, which includes:

- Election Offices
- Public Libraries
- Florida Driver's License/Tax Collector offices
- Centers for Independent Living
- WIC and Florida Department of Children and Families offices
- Armed Forces recruitment offices
- Several other public agencies

Contact the Supervisor of Elections Office for a complete list of voter registration agencies and additional locations where applications are available.

The Voter Registration Application may also be mailed or dropped off to any voter registration agency.

## **CLOSED PRIMARY, WHAT?:**

Florida is a closed primary state. In the Primary Election, you will vote only for the candidates whose party affiliation is the same as yours and for non-partisan races, unless a partisan race will be decided in a Universal Primary Contest, in which case everyone will vote in that race.

## **POLLING PLACES:**

On Election Day, polls are open at 7 am and remain open until all voters, who are in line to vote at 7 pm, have voted.

#### PHOTO AND SIGNATURE I.D.

Are required to be presented before voting. <u>If you do not present picture and signature identification, you will be</u> required to vote a provisional ballot.

#### **APPROVED IDENTIFICATIONS:**

Florida Driver's License

A license to carry a concealed weapon or firearm issued pursuant to s. 790.06

Employee I.D. card issued by any branch, department, agency, or entity of the Federal Government, the state, a county, or a municipality

### WHERE TO VOTE:

Your precinct number and polling location are listed on your voter information card. You will not be permitted to vote in a precinct in which you do not live. If you have questions regarding your polling location, please call the Supervisor of Elections Office.

#### **HOW TOREQUEST A VOTE-BY-MAIL BALLOT:**

Any registered/qualified voter may vote-by-mail. A ballot may be requested for a specific election or for all elections in one (1) election cycle. The request can be made in person, by mail, by phone, by fax, online or by e-mail. ONLY a voter or a designated member of his/her immediate family or legal guardian can request a vote-by-mail ballot for the voter. Immediate family means the voter's spouse, parent, child, grandparent, grandchild, or sibling of the voter or of the voter's spouse.

A request for a vote-by-mail ballot must include the name of the voter, the voter's address, the voter's date of birth and the voter's signature (if written request). The voter's Florida Driver's License number, Florida Identification number, or last four (4) digits of the voter's social security number must also be disclosed. If the voter has designated an immediate family member to request the ballot for him/her, the designee must also provide his/her own name, address, relationship to the voter, driver license number, the requestor's identification number, or the last four (4) digits of the requestor's social security number, if available. The requestor must also provide a signature for written requests only.

Vote-by-mail ballots must be received in the Supervisor of Elections office no later than 7:00 p.m. on Election Day.

If you have received a vote-by-mail ballot but wish to vote at an early voting site or in your precinct on Election Day, you must take the ballot with you to the polls, whether it has been marked or not. However, if you are unable to return the ballot, you may vote a provisional ballot if return cannot be verified by the elections office.

You must remember to update any address changes with the Elections Office. Vote-by-mail ballots cannot be forwarded and if they are returned as undeliverable, all subsequent requests will be canceled.

## **HOW TO VOTE:**

Each precinct will consist of at least one (1) DS300 (tabulator) and one (1) ExpressVote System (ADA Machine), accessibility for all voters as needed.

## OPTICAL-SCAN (DS300 TABULATOR):

After the ballot is marked, the voter will feed his/her paper ballot into the DS300 Tabulator, which will read and tabulate the ballot. Below is an example of how to properly mark the ballot.

Fill in the oval to the left side of the candidate chosen; if you wish to vote for a write-in candidate – write name on line provided, **and** then fill in the oval on the left side.

## TOUCHSREEN (ExpressVote):

Touchscreen technology that produces a paper-based record for tabulation.

Voting- Easy as 1, 2, 3

- Voter inserts blank ballot card into ExpressVote System.
- Voter makes and verifies their selections.
- Voter feeds paper ballot into DS300 Tabulator.

## CHANGES IN YOUR REGISTRATION:

It is the responsibility of the voter to keep his or her address and signature current with the Supervisor of Elections office. Be sure to notify the Supervisor of Elections office if you have a name change, an address change, a change in your party affiliation, or a signature update. If you move to another state, you must re-register there.

#### **REGISTRATION IS A PUBLIC RECORD:**

In Florida, voter registration records are open to the public. The Social Security number, Florida Driver's License or Florida identification number, along with the signature are exempt from public record. In addition, a voter's prior felony conviction and whether such person has had his or her voting rights restored by the Board of Executive Clemency or pursuant to Art.VI,s.4, State Constitution.

Preregistered individuals (16 and 17 years old) are also exempt from public inspection and copying requirements until they reach the age of 18. Anyone is entitled to a list of registered voters and their voter history.

#### **INACTIVE VOTERS:**

Voters on the inactive list can be reinstated by updating their voter registration, appearing to vote, or requesting a vote-by-mail ballot, providing their status has not changed. However, after two general federal elections, voters who show no activity will be removed from the registration records and must register again in order to vote.

## **VOTER RESPONSIBILITIES:**

Each registered voter in this state should:

- 1. Familiarize himself/herself with the candidates and issues.
- 2. Maintain a current address with the Supervisor of Elections.
- 3. Know the location of his/her polling place and its hours of operation.
- 4. Bring proper identification to the polling place.
- 5. Familiarize himself/herself with the operation of the voting equipment in his/her precinct.
- 6. Treat precinct workers with courtesy.
- 7. Respect the privacy of other voters.
- 8. Report any problems/violations of election laws to the Supervisor of Elections.
- 9. As questions, if needed.
- 10. Make sure that his/her completed ballot is correct before leaving the polling station.

Note: Failure to perform any of these responsibilities does not prohibit a voter from voting.

#### **VOTER'S BILL OF RIGHTS:**

Each registered voter in this state has the right to:

- 1. Vote and have his/her vote accurately counted.
- 2. Cast a vote if he/she is in line at the official closing of the polls in that county.
- 3. Ask for and receive assistance in voting.
- 4. Receive up to 2 replacement ballots if he/she makes a mistake prior to the ballot being cast.
- 5. An explanation if his/her registration/identity is in question.
- 6. If his/her registration/identity is in question, cast a provisional ballot.
- 7. Written instructions to use when voting, and upon request, oral instructions on voting from the elections officers.
- 8. Vote free from coercion or intimidation by the election officers or any other person.
- 9. Vote on a voting system that is in working condition and that will allow votes to be accurately cast.

### 2024 ELECTION DATES:

Presidential Preference Primary Election -- March 19, 2024

Books Close -- February 20, 2024

Primary Election-- August 20, 2024

Books Close -- July 22, 2024

**General Election**-- November 5, 2024 **Books Close** -- October 7, 2024

**NOTE:** Registration books close 29 days prior to each election. If you submit a properly completed application form during this period, you will be registered to vote in future elections.

#### THREE WAYS TO VOTE:

Early Voting, Vote-by-mail and Voting in your Precinct on Election Day.

## WHO CAN REGISTER?:

Must be a United States citizen; is at least 18 years of age (you may preregister at 16); a legal resident of Florida; is a legal resident of the county in which that person seeks to be registered; registers pursuant to the Florida Election Code.

## WHO ARE NOT ENTITLED TO VOTE?:

A person who has been adjudicated mentally incapacitated with respect to voting in this or any other state and has not had his or her right to vote restored; A person who has been convicted of a felony by any court of records and has not completed all terms of his or her sentence; If you are unsure of your status, please give our office a call; A person who is not registered may not vote.
